Bo Helms called the meeting to order followed by the pledge of allegiance at 6:00 PM.

Matt De Leo joined the meeting via video conference call to inform the board of the tax rate formulas and answer any questions anyone might have. Discussion occurred from 6:00 PM-6:15 PM'

The consent agenda, which included the Kay Concrete and Construction invoices for \$7374.00 and \$18,911.75, has been tabled for now. The board wants an itemized billing on the Kay Concrete invoice for \$18,911.75 before the invoices are paid.+

New Business:

The board reviewed the HUDL agreement for activities.

Kelly Kohler moved to approve the HUDL agreement in the amount of \$29,700 for three years in the billing amount of \$9,900 a year for the 2024-2025, 2025-2026, and 2026-2027 school years seconded by Derek Tuttle, 7-0 motion carried.

A discussion was held on the funding of HUDL. The school board would like to have further discussion on this issue at the September board meeting with Steve Carvajal and Jason Culpepper in attendance.


